Pupils' behaviour on in school does not comply with social distancing guidance when working outside their bubbles/classroom bases

- Clear messaging to pupils on the importance and reasons for social distancing is reinforced throughout the school day by staff and through posters and floor markings. For young children this is done through age-appropriate methods such as stories and games, using new Behaviour Policy appendix.
- Staff model social distancing consistently.
- The movement of large numbers of pupils around the school is minimised/staggered
- Large gatherings are avoided.
- Break times and lunch times are structured to support social distancing and are closely supervised including use of toilets.
- The school's behaviour policy has been revised to include compliance with social distancing and this has been communicated to staff, pupils and parents. (Behaviour Policy Appendix)
- Senior leaders monitor areas where there are breaches of social distancing measures and arrangements are reviewed.
- Messages to parents reinforce the importance of social distancing.
- Arrangements for social distancing of younger primary school children have been agreed and staff are clear on expectations.
